Dear Secretary Bose:

On June 9, 2011, WSPP Inc. ("WSPP") submitted in this proceeding revised pages to Schedule Q of the WSPP Agreement to incorporate a cost-based rate schedule for short-term wholesale power sales for Westar Energy, Inc. ("Westar"), a member of WSPP ("June 9 Filing"). WSPP requested an effective date of June 1, 2011 for these revisions.

It has come to WSPP's attention that a revision to the Schedule Q index was inadvertently omitted. Specifically, while the Westar cost-based rate schedule was incorporated into Schedule Q in the June 9 Filing, the Schedule Q index was not revised to reflect incorporation of Westar's cost-based rate schedule. Therefore, WSPP now amends the June 9 Filing to include the revision to the Schedule Q index.

This filing does not in any other manner modify or amend the June 9 Filing. WSPP requests that the Commission accept the revisions to the WSPP Agreement submitted in the June 9 Filing, as amended by this filing, and grant a June 1, 2011 effective date, as previously requested.
